Call to Order: Mr. Kaden opened the meeting at 6:30 p.m.

Executive Session: Motion by Mrs. Carey, seconded by Mrs. Brieff, be it Resolved that the Board go into Executive Session to discuss the employment history of a particular person.
Motion carried unanimously.

Motion by Mrs. LaCara, seconded by Mr. Nitkewicz, be it Resolved that the Executive Session be adjourned.
Motion carried unanimously.

Mr. Kaden opened the Business Meeting at 7:30 p.m. and led the audience in the Pledge of Allegiance.

Musical Presentation: Dr. Bennardo expressed holiday greetings to the audience and introduced the Countrywood Singers. They put on a delightful performance led by music teacher Adam Slawitsky that was enjoyed by all in attendance. Mr. Kaden thanked the students for their wonderful performance.

Board Recognition of the WWHS Varsity Soccer Team's NYS Championship Title: Dr. Bennardo congratulated the Walt Whitman High School Varsity Soccer team members, as well as their coaches—Mr. John DiGiacomo and Mr. Brian Karcz—for a fabulous fall ride straight through to the New York State Championship Title. Dr. Bennardo reminisced about a practice he watched in an absolute downpour of rain. The soccer athletes consistently practiced the corner kicks, despite the awful weather conditions. Dr. Bennardo stated that the team understood the value of hard work, which has brought them to this level of excellence. He

thanked each team member, and their coaches, for bringing such pride and excitement to the South Huntington community. Each team member received a Certificate of Achievement denoting the New York State Championship Title designation, as well as a team proclamation and a second proclamation for the coaches. All members of the team were congratulated by the individual Board trustees. Dr. Bennardo shared that on January 22, 2016, the Varsity Boys Soccer Team will again be honored during a basketball half-time ceremony.

Dr. Bennardo introduced Assemblyman Lupinacci, a proud graduate of Walt Whitman High School. Assemblyman Lupinacci congratulated the team for their extraordinary record. He shared that he attended the County playoff game at Farmingdale University and was extremely impressed with their level of play. Assemblyman Lupinacci stated that he served on the Board of Education for nine years prior to becoming an assemblyman. In addition, he shared that he graduated with Coach Karcz, and watched Coach Karcz in the County playoffs back in 1996. The Assemblyman provided Citations of Merit to each player, as well as a proclamation for the team. The Assemblyman shared that the State Assembly and Senate were on recess, and upon their return on January 6, 2016, a resolution declaring the Walt Whitman High School Boys Varsity Soccer Team's designation of the 2015 New York State Championship Title will be passed by the New York State Assembly and Senate, cementing this historical event in the official record books. With this statement, the Assemblyman received applause for this worthy endeavor. In closing, Assemblyman Lupinacci thanked the team, the coaches, and the parents in the audience.

It is estimated that each set is valued at \$500, and there will be approximately 15 sets in the district being utilized at any given time, for a value of approximately \$7,500.

partnership and further explained that the television sets were donated after only one year of use in various businesses. Dr. Bennardo expressed his thanks for their charity. The units are being used to highlight student activities in the various buildings throughout the district.

National Dance Alliance Agreement:

Dr. Bennardo stated that this is an annual trip for our high school music performing groups, who typically compete very well at the event.

Request to Remain in South Huntington Schools: Motion by Mr. Nitkewicz, seconded by Mrs. Brieff, be it Resolved that the Board of Education of the South Huntington Union Free School District hereby approves the request of parent that her son remain in Walt Whitman High School for the remainder of the 2015/2016 school year with transportation to and from school being furnished by parent, a copy made part of these legal minutes, p. 798.

Mr. Kaden asked for a show of hands:
Ayes – 6; Noes – 1, Mr. Ciappetta opposed.
Motion carried.

Mrs. Harris reported that the student was a senior and resided in the Huntington School District. The student had previously attended the Huntington High School for approximately 1.5 years, moved back to the South Huntington School District, and recently moved back to the Huntington School District. Mr. Kaden asked how recently did the family move back to the Huntington School District; Mrs. Harris responded she was not certain, however, the situation became known from the bus driver, who viewed the student being dropped off each day to the bus stop. An investigation was conducted, and the findings were that the family resided to the north of our boundary line. Discussion ensued regarding the request being forwarded after it was discovered that the student was illegally attending Walt Whitman High School. Mr. Nitkewicz expressed his concern for not wishing to punish the student for a decision made by his parents. Mrs. Brieff questioned the past practice pertaining to similar requests. Dr. Bennardo shared that with the start of the third quarter, it was an automatic approval, but at this point in time, consideration was provided on a case-by-case basis. Mrs. Harris added that given the stability that the student received at Walt Whitman High School, it was more likely that the student would graduate. The student had Mr. Blair working closely with him, who believed the student had the potential to graduate. The question was posed if there were family members attending school in the Huntington School District; the response was positive. Mr. Nitkewicz again conveyed his opinion that the Board should not be punitive with its decision. However, Mr. Ciappetta stated his disagreement in that the request was made after it was revealed that the family did not reside within our boundaries. Mr. Ciappetta further stated that he did not believe that the Board should approve this request, as the family violated District policy.




Adjournment:
