Call to Order: Mr. Ciappetta opened the meeting at 7:30 p.m. and invited Girl Scout Troop 954 to approach; the Girl Scouts led the audience in the Pledge of Allegiance.

Mr. Ciappetta welcomed all to tonight's meeting with two eventful presentations scheduled. Mr. Ciappetta was delighted to share the news that Dr. Bloom and Principal Murphy were to be recognized by the Suffolk County Martin Luther King, Jr., Commission on January, 12, 2018, with the "My Brother's Keeper" award. He also reported that Dr. Bloom will be honored by the Long Island University's Phi Delta Kappa Chapter 1525 as this year's Distinguished Leadership Award recipient for professionals in education. The celebration awards ceremony will take place on April 19, 2018.

Holiday Musical Presentation:

Mr. Ciappetta introduced Mr. Adam Slawitsky and the Countrywood Singers, who sang a melody of holiday songs to the sheer delight of their parents, siblings, grandparents, Board of Education, administrators and residents. The stage was adorned with snowflakes suspended from the ceiling that sparkled and twirled while the students sang. It was a perfect winter wonderland backdrop to a heartwarming performance.

Science Academic Presentation:

Mr. Maddy began the Science Presentation with the Vision Statement that emphasized fostering a spirit of inquiry, nurturing students' curiosity, and bringing current, relevant and real-world science into the classroom experience in preparing students to become educated citizens capable of comprehending and analyzing global issues. The three phases of the new Science standards were reviewed:

Phase I – Initial Transition Raise Awareness and Build Capacity

Phase II – Transition and Implementation

Phase III – Implementation and Sustainability

Dr. Michaelian shared the numerous K-5 program highlights that engaged hands-on learning through investigations developed by BOCES (ESP) and Carolina Biological (Life Cycles, Electricity, Magnets & Motors, Motion & Design, Botany and others), as well as Science Practices through ZSpace virtual labs, combined with real field experiences, such as the Vanderbilt Planetarium, Sweet Briar Nature Center, Sunken Meadow, Caumsett, Park Shore and others. Dr. Michaelian reported on Design Challenge kits that support engineering practices, a gradual transition to NYS Science Learning Standards, implementing one unit per year in each grade. She accentuated that there was increased emphasis on engineering/problem solving, and a strong connection to literacy and mathematics. There was a shift from learning about a Science idea to developing and using the Science idea, producing a much deeper level of understanding.

Principals Smith and Murphy reviewed the program highlights for Grades 6-8 and Grades 9-12 and the various grade-level accelerated classes, including electives.

Principal Murphy addressed the three-year trends with the NYS Science Regents Exam Living Environment reflecting an increase in proficiency and mastery for all students and increases across the board for ENL, economically disadvantaged, Black, Hispanic and special education students. A similar trend existed for the Earth Science Regents, with even higher increases noted at each level. The Chemistry Regents yielded substantial increases as well and reflected ENL students taking the test, where none had taken the exam in 2015. Principal Murphy shared that of the nine students who took the test, eight passed the Regents. The trend for Physics was reviewed, again with similar increases in proficiency and mastery levels, however, there was a decline in the number of economically disadvantaged and Black students taking the Physics Regents, a concern articulated by Principal Murphy. The three-year trend for college level and advanced placement courses was reviewed noting substantial increases—namely, a 20% increase in the number of students taking Science AP exams; a 23% increase in Hispanic students receiving a 3 or higher on AP exams; 76% of students achieving a 3 or higher; 42% of students achieved a 4 or 5; and there was a 27% increase in the number of students taking a fourth-year Science course.

Areas of focus were shared—closing the achievement gap, continued professional development for teachers; continued use of technology within the curriculum, and a strong commitment to developing students' skills, as well as teacher instructional practices with the new NYS Science Learning Standards.

Mr. Macaluso concluded the presentation, "Tying it all Together," and

reported that there was a variety of course offerings at multiple levels ensuring that students continued with science for all four years—in fact, 77% of the senior class was enrolled in a science course. Mr. Macaluso also stated that additional supports, such as AIS, learning labs, Regents prep, Regents Prep Academy and the Lab Support Program ensured student success and continued enrollment. He added that with the increased proficiency demonstrated on Regents exams, there was an 11% increase in Advanced Regents Diplomas since 2015. The performance and enrollment in AP science classes reflected a rigorous academic science program, as well as an enhanced ability for students to be accepted to top colleges. Lastly, Mr. Macaluso reported that guidance counselors continued to encourage all students to enroll in science courses that challenged them academically and best prepared them for college.

Motion carried unanimously.

Mr. Ciappetta congratulated Ms. Dell and Ms. Tedesco, the long-time co-presidents of the Paraprofessional Association, and expressed how much the Board appreciated all that their unit members did for our students. Mr. Nitkewicz expressed similar sentiments.

Motion carried unanimously.

Mr. Ciappetta reported that the request to remain in South Huntington Schools was for the duration of the current school year (the student's junior year) and for the 2018/2019 school year (the student's senior year). This request, Mr. Ciappetta shared, was definitely out of the norm, as the typical request was for the duration of the current school year only, with greater consideration given to moves after the semester break. He added that the Board Policy permits students whose parents/guardians have moved outside the attendance boundaries of the District to conclude the school year in their current building of attendance. This request for the conclusion of the current school year, as well as the following senior year, was highly unusual.

Mr. Nitkewiz stated that the student's parents purchased a home thought to be located within the District's boundaries, only to find out after the sale that it was in a neighboring district. While the situation was unique, Mr. Nitkewicz communicated his commitment to the student and his desire to approve the request.

A lengthy discussion ensued and several Board members articulated their concern for the cost to the taxpayers, as well as adherence to the Board Policy, and were not comfortable with approving the student remaining as requested. Mrs. LaCara shared that in her 12 years of service on the Board, she had no recall of ever approving such a request, and further stated that the cost of doing so was an issue.

The suggestion was made to approve the student to remain for the current school year only, and if the parent rented and relocated to an apartment within our boundaries, the student could remain for the following year as a senior. Again a robust discussion ensued regarding this concept. Concern was shared for the student that if parents could not relocate, it would be prudent for the student to start in the neighboring district as quickly as possible. Mr. Nitkewicz was not pleased to share the negative response one week prior to the Christmas holiday, however, Mr. Bronson responded that if the student were not to stay in the senior year, it would be easier for the student to leave South Huntington now.

Mr. Ciappetta requested a motion to approve the request as submitted. Motion by Mr. Bronson, with a second from Mrs. Carey, be it Resolved that the Board of Education of the South Huntington Union Free School District hereby approves the request for the student to remain in the District throughout the student's senior year.

Motion denied; Mr. Nitkewicz casted the sole yah vote.

Discussion ensued regarding the timing of the year for formal approval to remain in the district; Mr. Ciappetta concluded that at this point it was very close to the beginning of the second semester for approval consideration.

Mr. Nitkewicz moved, with a second from Mr. Bronson, that the Board amend the approval of the request as follows and moved its adoption:

Be it Resolved that the Board of Education of the South Huntington Union Free School District hereby permits the parent request to allow the student to remain in our District to the end of the student's junior year only, so long as the residency remains outside of the South Huntington Union Free School District, a copy made part of these legal minutes, pp. 884-888.

Be it Resolved that the request to remain in South Huntington Schools as amended, be adopted.

Motion carried unanimously.

**SEQRA Resolution
re Renovations at
Teen Center:**

Mr. Bronson offered the following resolution and Mr. Nitkewicz moved its adoption:

WHEREAS, the Board of Education of the South Huntington Union Free School District desires to embark upon a capital improvement project at the Teen Center for the Renovations at the existing facility and,

WHEREAS, said capital improvement project at the Teen Center is subject to classification under the State Environmental Quality Review Act (SEQRA); and

WHEREAS, replacement, rehabilitation or reconstruction of a structure or facility, in kind, on the same site, including upgrading buildings to meet building or fire codes, unless such action meets or exceeds any of the thresholds in Section 617.4 of this part, are classified as Type II Actions under the current Department of Environmental Conservation SEQRA Regulations (Section 6 NYCRR 617.5 (2)); and

WHEREAS, the SEQRA Regulations declare Type II Actions to be actions that have no significant impact on the environment and require no further review under SEQRA; and

WHEREAS, the Board of Education of the South Huntington Union Free School District, as the only involved agency, has examined all information related to the capital improvement project and has determined that the capital improvement project for the Renovations at the Teen Center is classified as a Type II Action pursuant to Section 617.5 (2) of the SEQRA Regulations;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education of the South Huntington Union Free School District hereby declares itself lead agency in connection with the requirements of the State Environmental Quality Review Act; and

BE IT FURTHER RESOLVED, that the Board of Education of the South Huntington Union Free School District hereby declares that the Renovations

at the Teen Center are a Type II Action, which requires no further review under SEQRA; and

BE IT FURTHER RESOLVED, that the Board of Education of the South Huntington Union Free School District hereby shall move forward an official copy of this Resolution to the New York State Education Department together with a copy of the correspondence from the New York State Office of Parks, Recreation and Historic Preservation in connection with its request for approval of the listed projects from the New York State Education Department.

Committee Updates:

Mr. Ciappetta provided a recap of the Facilities Committee meeting that took place on December 5, 2017. Other than the boilers in Stimson and Silas Wood, all are the original units installed when the buildings first opened. The age of the boilers presents problems with efficiency and with securing replacement parts. There was also a review of the fields and an irrigation update, as well as discussion on future plans for the Performing Arts Center. Additionally the bleachers at Walt Whitman High School require some work—they are structurally sound, but do require painting. Mr. Ciappetta also reported that the Facilities Survey has been released via Spotlight, the website and email, and he urged residents to submit their completed surveys. The information will be most useful with consideration of a future bond.
